## **WHAT IS AB928?**

- AB 928 is also known as the Student Transfer Achievement Reform (STAR) Act of 2021
- It's a law designed to simplify the transfer process for CCC students
- Main impacts:
  - All students who indicate they plan to earn an AA degree and transfer must be put on an ADT pathway (effective Fall 2024)
  - Creates a singular GE pattern for transfer students, Cal-GETC, to replace the former CSU GE and IGETC patterns (effective Fall 2025)

## **AUTO ADT PLACEMENT**

Per AB928, if an ADT pathway exists, students must be placed into it unless they meet the statutory exceptions. Statutory exceptions from auto-ADT placement include:

- 1.An ADT pathway does not exist in the chosen major at the college. 2. The student's educational pathway is better served by a local
- associate degree.
- 3. The student plans to apply to transfer to a UC campus or an independent college or university.
- 4. The student is seeking to complete a community college baccalaureate degree program.
- 5. The student is seeking to complete a CTE program that does not have an ADT pathway.



## WHAT IS CAL-GETC?

- The California General Education Transfer Curriculum (Cal-GETC) is the new singular transfer general education pathway for California Community College (CCC) students to fulfill lower-division general education requirements for transfer and admission to the CSU and UC systems.
- Cal-GETC shall be used for new incoming students in Fall 2025.
- Cal-GETC will replace the CSU GE Breadth and IGETC patterns.

## **CAL-GETC APPLIES TO THE FOLLOWING**

### **NEW STUDENTS**

New Incoming students to the CCC begining Fall 2025 and beyond.

### **CONTINUING STUDENTS**

Students with catalog rights\* prior to Fall 2025 may choose to complete Cal-GETC, but it is not required. \**Catalog rights are a local decision; Cal-GETC is effective Fall 2025.* 

### **EXTERNAL CREDIT STUDENTS**

Students with external credits from in-state private or out-of-state institutions who do not have catalog rights.

## **CAL-GETC IS NOT INTENDED FOR:**

### LOCAL AA/AS DEGREE SEEKERS

Students who are earning an AA/AS degree using local general education requirements and do not plan to transfer.

### **DISCONTINUED STUDENTS**

Students who have stopped out and do not have rights to Fall 2025 term.

### **ADT HOLDERS**

Students who have already earned an ADT.

### **GE CERTIFIED**

Completed full CSU GE Breadth or IGETC certification, whether noted on the CCC transcript or otherwise.



## **CAL-GETC REQUIREMENTS**

- All Cal-GETC courses must be UC-transferable.
- Most IGETC-approved courses rolled over to Cal-GETC, except Area 1C.
- A minimum grade of "C" or "P". "P" grade is acceptable if equivalent to a "C" or higher and grading policy is reflected on the college transcript key or catalog; a "C-" is not acceptable.
- <u>All courses</u> must have at least 3 semester or 4 quarter units. • Exception: Only lab courses that are paired with a lecture may be 1 unit; all other courses must meet the minimum unit requirement.
  - Exception: Math and English sequence courses.

### AMERICAN INSTITUTIONS (AI) <u>OPTIONAL</u> REQUIREMENT FOR CSU

Counselors can still highly recommend American Institution courses for CSU-bound students. The Al requirement is not a part of Cal-GETC but those courses can still be used to count for both areas (as it is now). UC may require American Institutions requirements for students who did not graduate from a California high school.

## LANGUAGE OTHER THAN ENGLISH (LOTE) **OPTIONAL REQUIREMENT FOR UC**

**EVALUATORS** 

Continue certifying as you have previously.

More guidance to come out in May; subject to change.

### COUNSELORS

May recommend certifications based on students' transfer goals.

## **GE CERTIFICATIONS**

Only full Cal-GETC certifications will be sent to CSU or UC if requested partial certifications are not allowed.

There is no Cal-GETC STEM option.

All ADTs will require full completion of Cal-GETC to be awarded.

# **UPDATE YOUR** CERTIFICATION FORGET

### **Students admitted pre-Fall 2025**

- Students may use the CSU GE or IGETC version that was in effect when they first enrolled at a California Community College, as long as they have continuous enrollment.
- There is no sunset date for CSU GE Breadth or IGETC courses currently approved for CSU GE and IGETC can continue to be used in those patterns.

### **Students admitted pre-Fall 2025**

**Continuous Enrollment Scenarios:** 

- Students who started in 2022–2023 may follow IGETC 2.3 or later.
- Students who started in 2023–2024 may follow IGETC 2.4 (which adds Area 7–Ethnic Studies and updates Area 4–Social and Behavioral Sciences) or later.



### **Students Admitted Fall 2025 and Beyond**

Students must complete Cal-GETC to fulfill general education requirements. CSU GE Breadth and IGETC are not options for these students.

### **Middle High School or High School Students**

- Evaluators review degrees based on catalog rights, not high school status.
- For Cal-GETC eligibility, we confirm that the student is enrolled in Fall 2025 or later.
- If a student completes an ADT while in MHS or HS or during their first college term in Fall 2025, we will award the ADT as long as they are enrolled in Fall 2025 or later and have met all requirements.
- Once the ADT is awarded, the CSU or UC should not challenge the certification if they have enrollment in Fall 2025 or later.
